Chairman of the Board - Bob Clark

In April I traveled to Ames, IA to participate in an advisory committee, "Managing Water for Increased Resiliency of Drained Agricultural Landscapes." The project team has twenty members made up of researchers and extension specialists from eight universities and USDA research sites. My role is to keep drainage contractors informed of the progress, results and tools developed. It is a good opportunity for LICA.

President - Steve Anderson

Steve went to the New Jersey Convention. Wrote an article for the Drainage Contrctor magazine. Planning on attending many state golf outings.

Treasurer - Mike Cook

Before you are the financial statements for LICA nine months ending June 30, 2015. Dues are \$25,000 over budget. Expenses should be at 75%. Printing and Publications are over budget due to printing new member folders and promotional material. Scholarships are over budget, but will be covered by a donation from the Ladies Committee. We should stay within budget for the last three months. Two hundred thousand of the \$331,944 is in a CD per the by-laws.

Executive Committee- Brad McArdle

The Executive Committee met Tuesday night. All officers gave reports on activities since the winter meeting. Jerry gave a report on his travel and what is happening on the national level. The budget for 2015/2016 was reviewed for presentation to the board.

Chief Executive Officer - Jerry Biuso

Since the convention in Tampa I have been traveling focusing on membership as well as developing the new chapters. It has been hectic and crazy in a very positive way. It is a fact when I travel membership increases and is reflected in the membership report. After including all the drops we are in very good shape. As you review my report you can see the positive activities occurring throughout the country. As of June 30th we have recruited 158 new members and that number increases every day.

New Chapters - It is a very difficult undertaking starting a new chapter. You first must establish the need, then find someone in the state with a sincere interest and the ability to carry it through. Arkansas was my first attempt I can say they are well on the way with more members (42) than some long time state chapters. The other new chapters I am working with are Maryland, Delaware, North Dakota and Texas. Texas will be most challenging. Florida has re-organized and soon will return as a chapter.

CEO Report (continued)

Membership –I have worked with New Jersey who has 28 new members. I have also helped New York and Pennsylvania LICA recruit new members. I held membership drives; three days in Maryland and six days in Nebraska. I have discussed a program with California LICA.

National Conventions – I conducted two site inspections one in San Antonio and the other in Colorado Springs with Nordis Estrem. I successfully secured the Drury Hotel in San Antonio on the River Walk and the Elegante in Colorado Springs. I am scheduled to visit three hotels July 26-29th in Kansas City the site of the Summer 2016 meeting with Deb Dickens.

IECA - As a result of the lunch we hosted in Washington DC we began a partnership with IECA (International Erosion Control Association). Please see article in the summer magazine. We did exhibit at their convention in Portland and they will also exhibit at our Associates night on Thursday. They will hold their 2016 Convention in San Antonio just before ours.

NACD – I seek to develop a stronger relationship with this association (National Association of Conservation Districts). I believe they can a source of revenue for our members.

Wastewater Management -This is now a national focus to recruit contractors performing this service. Illinois, Pennsylvania and New Jersey LICA have launched initiatives in this area. New Jersey had 41 attendees from 24 different companies. Out of those 9 where not LICA members. New Jersey gained 12 members, 3 from the United Fire Insurance Program.

The World of Asphalt - Baltimore, MD, March 17-19, 2015 I attended the show with the president of Maryland LICA Megan Callahan and John Brown the President of Delaware LICA. The show was well attended by predominately east coast contractors.

CONEXPO 2017 - Attended the Supporting Organization Program – Co Locating Associations - April 23, 2014 meeting in D.C.

Conference for Association CEO's - 100 association leaders gathered in New York City to explore the changing nature of networks and their impact on associations. Associations: 2020 and Beyond offered a forum for association leaders to share best practices and learn from those already taking steps within their own associations in preparation for the future. A key issue discussed was declining membership off 30% in the past ten years. LICA was the only association reporting an increase in membership!

Minutes from the Legislative Committee Meeting held at the February Winter Meeting in Tampa were read by John. Dirk Riniker moved their approval, seconded by Mike Koehne. The minutes were approved as presented.

John then led a discussion on the following topics.

EPA changes to the WOTUS definition.

The US Environmental Protection Agency's (EPA) proposed changed to waters of the US (WOTUS) as defined in the Clean Water Act of 1972 were published in the Federal Register on June, 29th and will become effective in August 28, 2015. EPA received over one million letters in opposition to the new definition from various individuals and groups throughout the country during the comment period.

John distributed an analysis of the final rule prepared by the National Association of Conservation Districts (NACD) and a side-by-side comparison of the initial and final regulatory language prepared by the Congressional Budget Office (CBO). The CBO document is quite good but very complex. He also noted that the US House of Representatives passed legislation that would prohibit the EPA from using funds to enforce these new regulations. The Senate will not likely will proceed with like

legislation, but it is anticipated that any bill passed by the Congress would be vetoed by the president.

The first of many anticipated lawsuits opposing the new regulation has already been filed by the American Farm Bureau and other groups. It is likely that legal and legislative initiatives will be abundant and will go on for quite some time. It is also likely that the new regulation may initiate scrutiny of existing agricultural exemptions.

Deb Dickens noted that Missouri has joined a suit that opposes the WOTUS changes on the basis that it violates states' rights.

Probably bigger then the WOTUS redefinition, is what may be happening to the Ag Exemptions in Sec. 404 of the CWA. This could have a big impact on those LICA contractors particularly in the Midwest whose work is with farmers. The so-called ag exemption may be disappearing. Here are some of the things happening that may cause this change.

- •Long held CWA ag exemptions could be in jeopardy following a ruling by the US Court of Appeals in American Farm Bureau Federation et al v EPA. The judges disagreed with the Farm Bureau and 8 other organizations that the CWA left no room for EPA to set strict standards and deadlines when issuing a TMDL for a waterbody.
- •The above ruling and a lawsuit brought by the Des Moines, IA Water Authority against upstream tile drainage districts for bringing too much nitrogen into the Raccoon River, could result in the discharge from those districts being considered a "Point Source." Right now provisions in the CWA exempt agriculture from being a regulated point source.
- •Also a recent case in CA decided that Confined Animal Feeding Operations (CAFO's) that were previously covered by the ag exemption were a point source.

If the ag exemption is lost, it could really impact how LICA Contractors work with their farmer clients, particularly those doing subsurface drainage. And since LICA Contractors are often the people farmers look to in understanding these things, LICA Contractors should be prepared to help their clients do the best job they can in preventing pollution. The technology does exist.

Highway Trust Fund Reauthorization.

The US Congress has, once again, chosen to use stop-gap, short-term measures to deal with the issue of the Highway Trust Fund expiring and the end of July. All indications are that this will continue to be the strategy for the foreseeable future. While many, including LICA, could support an increase in the federal gas tax if the money were only used for highways and bridges, many on both sides of the aisle don't want to raise taxes. The gas tax has not been raised since 1993, and much of the money currently goes to other than roads and bridges. A position paper on the subject has been drafted and will be taken up by the LICA Executive Committee in the near future.

Power Plant Rules.

LICA supported passage of HR 2042, the Ratepayer Protection Act, which would delay implementation of EPA proposed rule under Sec. 111 (d) of the Clean Air Act to regulate greenhouse gas emissions from existing power plants until such times as all judicial review has been completed. LICA has signed on to a letter to Fred Upton, Chairman of the US House Committee on Energy and Commerce, asking Members to vote "yes" on H.R. 2042. LICA joins approximately a dozen similarly interested groups signing in this letter.

Minnesota Governor's Buffer proposal.

Mark Morriem talked of a recent issue in Minnesota proposed by Gov. Dayton that would require establishing a 50' buffer along rivers, streams, and drainage ditches. Additionally, unlike current regulations that reimburse landowners for loss of cropland when such buffers are established, this proposal does not continue the same reimbursement policies. Mark also indicated that this regulation would be subject to much litigation.

The Northern Long-Eared Bat.

LICA has worked with a number of other groups that oppose the listing of the Northern Long Eared Bat as endangered by the Fish & Wildlife Service (FWS).

The bat is dying from something called the White-Nose Syndrome, which is not caused by humans. Listing could affect human activity in 39 eastern states plus DC. The problem is the Endangered Species Act (ECA) is not a good tool for dealing with something not caused by humans, since all it can do is curtail human activity in the problem area. The FWS will probably list the bat as endangered. Many of the groups we are working with are prepared to litigate. We will likely still support them, but not financially.

Dallas HUD Case.

John talked of HUD's twisting of the 1968 Fair Housing Act to assume that if low income minorities cannot afford to live in an expensive suburb. HUD assumes the community is racist and must "affirmatively further diversity" by "providing adequate support to make their choices viable." Along with controversial decisions on Obamacare and "homosexual marriage," the sharply divided Supreme Court ruled 5-4 that the Fair Housing Act allows people to challenge zoning laws that "may have a harmful impact on minority groups" even if there is no proof that government agencies intended to discriminate. This case involved an appeal from Texas officials accused of violating the Fair Housing Act in a way that kept low-income housing out of expensive. and mostly white, neighborhoods. A federal appeals court said a Dallas-based fair housing group, The Inclusive Communities Project, Inc., could use statistics to show that the effect of policies, even if those policies had no intent or motive to discriminate, appeared to be racist and had a "negative impact" on black residents. Texas officials argued it was not right to have to justify or change policies that don't racially discriminate.

Wisconsin State Prevailing Wage Reform.

Wisconsin is dealing with action to reform state prevailing wage programs. Although these moves have high political visibility, Diane Curtis said they may not have any real effect on building

costs in WI since many of the projects involved are already subject to federal prevailing wage mandates.

Con Expo Educational Seminars.

John Peterson relayed a request from Jerry Biuso, National LICA CEO, that committees begin considering topics for educational programs at the next Con Expo conference.

Dan Micsky proposed that we have a LICA panel to educate legislators of the impact of the federal excise tax on our industry. LICA Members could invite their legislators to Con Expo, have them look at equipment costs with the LICA Members and the amount of excise taxes collected, and discuss not only the tax, but what it is used for. The tax is about 12-13% of equipment cost.

An additional topic may be implementation of WOTUS as it stands at the time of Con Expo. Nordis Estrem made a motion for adjournment, seconded by Vern Krivanek. The meeting was adjourned at 9:45 a.m.
